A mutual agreement was reached for him to just walk away from the contract. Painting award was then given to the second low bidder, J.K. Painting, who had previously done work for the Authority. The remaining term of the contract is about one year.

#### **EXECUTIVE DIRECTOR'S REPORT & UNFINISHED BUSINESS**

Mr. Snyder said under Correspondence there were four RFPs that came out today: landscaping, HVAC, closed-circuit television and plumbing.

For the Energy Performance Contract, HHA signed a contract with Tozour Energy to do the energy audit, which will list the energy conservation measures: changing lights, changing toilets, etc. There was a kick-off conference call with them last week. The next thing will be a list of all proposed items to do.

A contract was awarded a while back to renovate the elevators in all buildings. They are starting Saturday of this week to repair the interiors, particularly the mustard color. Commissioner Casamenti asked what it would be now. Mr. Snyder said wood grain panels.

Bed bugs have been an issue, as in every housing authority. Richard Cooper, an entomologist from Rutgers University, is working with the staff here. Mr. Cooper is impressed by everything the Authority is doing to eradicate the problem. There is a company that puts insecticide in their paint, which is used behind cabinets, and helps with roach problem. Now that company has gotten approval from the Federal Government to use a product to kill bed bugs. Through the Capital Fund, the Authority is going to be purchasing a closed-end trailer which will contain a washer/dryer so that when the units that are being treated, everything can be

taken out of the apartment and treated outside so the existing washer/dryer is not contaminated.

Mr. Snyder said he had the signs designed for no smoking and before fines are invoked, but there is an issue right now about if the fines can be invoked. Mr. Snyder will have a meeting to talk about what has to be done before the signs can be displayed. Once the signs are up, Mr. Snyder will meet with Mr. Asadurian about the problematic heavy smokers.

#### HACKENSACK POLICE DEPARTMENT

Sgt. Smith is now in charge of the Hackensack Police Department officers at the Housing Authority. The report from the HPD will be turned in Monday to the office. There are no major incidents or problems to report.

### **BOYS & GIRLS CLUB OF HACKENSACK**

Sonia Verdade presented her report to the Commissioners. At this time there are 125 members. Her report listed the many events held for the children:

- 3. Black out event at Lodi Facility fundraiser where 129 youth attended

- 8. Smart Moves Program

Sonia said there will be Tricky Tray fundraiser at the Venetian in Garfield. Tickets are \$55. Money raised will be split between Lodi and Hackensack. Kohl's Cares of Nanuet is planning an event and will donate \$1,000 to the Boys & Girls Club of Hackensack. Her report also included other statistics: there are 74 single parent households, ethnicity, age frames, attendance, etc.

Sonia asked the Board if a quarterly report would be adequate. Everyone agreed that would be fine. Chairman Saccaro asked how much was raised at the sleepover held in Lodi. Sonia said \$1,300 was raised. There were 130 children from the middle school.

#### **REMARKS OF CITIZENS**

PEDRO COOK, 10C, said water is coming into his apartment. He has lived here six years and has had water 3-4 times previously. Last Wednesday there was a heavy

rain and wind. He used a pail and mop, ¾ of the room had water on the floor. Pedro called maintenance at 4 AM, the maintenance man came at 5:15 AM and got flooding under control. Rain had stopped. The man left, said he'd come back, and returned with a pail. Pedro estimated 5-6 gallons of water, 3-4" of rain came in around the air-conditioner.

ISABELLE TILLERY, 8B, asked about the television in the Community Room. Only one channel can be seen. Mr. Snyder said people come and steal the cable wire or steal the remote and/or batteries. That is the problem.

She asked again about the exercise bike in the Community Room. Commissioner Casamenti said he'd checked on the bike and a pedal is missing. The bike works fine, it just needs another pedal.

MARY JONES, 7A, reported water is also coming into her apartment. She has not had this problem before, and it is not as much as Pedro had. Commissioner Casamenti asked if covers on the air-conditioners would help.
