#### MANAGEMENT REPORT & UNFINISHED BUSINESS

ED Feorenzo reported that BioReference Labs contacted HHA to schedule testing for CQVID-19 at various locations.

65 First Street – June  $2^{nd}$  – 10-2 PM – 50 people tested for antibodies or virus Kansas Street – June  $3^{rd}$  – 52 were tested

164 Beech Street & 175 W. Railroad – June 4<sup>th</sup> – 95 were tested Boys & Girls Club – June 9<sup>th</sup> – 72 were tested June 10<sup>th</sup> – 63 were tested

Vice-Chairman Stuart noted procedure went very quickly. Testing will be done in high school parking lot next Tuesday. Edgewater Housing Authority said anything related to COVID-19 testing will be reimbursed, laptops for office staff to use at home also. ED Feorenzo added HHA will be reimbursed for cleaning people two days a week.

Commissioner Allegretta inquired how many cases and how are numbers at HHA. ED Feorenzo answered he is not allowed by HEPA to share that information. Hearsay was 4 persons tested positive. Tenants are wearing masks outside.

Apartments available: there are 8 studios ready, 4 are rented as of July 1st. There are 5-one bedroom – 2 rented on July 1st. There is one 2-bedroom moving to a 1-bedroom soon. And one family is ready for a 2-bedroom.

The date and time of July meeting will be advertised in The Record and on web site of Hackensack Housing Authority.
