REQUEST FOR PROPOSALS

The Housing Authority of the City of Hackensack, New Jersey will accept proposals for garbage removal services. The term of this contract shall be October 1st, 2023 to September 30th, 2025. It is the Housing Authority's desire to retain and employ a duly qualified, licensed waste removal contractor. All services must be in accordance with the existing laws, rules, orders, directives and regulations governing these services.

The services that are requested will be as follows and will encompass one of the Housing Authority's properties (86 Newman Street):

Provide pickup services for an existing 30-yard container at times when requested by the Housing Authority. Price shall be per pick-up.

Qualifications:

- 1) Must be licensed by all applicable entities governing these services in the State of New Jersey.
- 2) Must have a minimum of three (5) years experience in the carting business.
- 3) Must be an approvable by the U.S. Department of Housing and Urban Development to provide these services.

Proposal Submission:

All persons interested in submitting a proposal for the Housing Authority's garbage removal services should submit a price based upon a flat fee for the weekly pickup and a flat fee for the 30-yard container pickup. The proposal must include the following:

- 1) Fee Proposal
- 2) Copy of the vendor's insurance certificate.
- 3) NJ Business Registration Form
- 4) Listing of references and current customers.
- 5) Copies of all relevant licenses.
- 6) Certification of equipment compatibility

Proposals should be delivered to the Housing Authority of the City of Hackensack, 69 First Street, Hackensack, New Jersey on or before Thursday, August 17th, 2023 by 11:00 AM. The buildings and containers are available for inspection between the hours of 9:00 AM to 4:30 PM, Monday to Friday.

The Housing Authority reserves the right to reject any and all proposals received for these services. It also reserves the right to terminate the vendor, for convenience, at any time during the term of the contract.

This solicitation for proposals is being made in accordance with the New Jersey Local Unit Pay to Play law (NJSA 19:44A 20.4 et seq.) as a "fair and open" process. All proposals will be publicly opened on the date and time specified in the RFP.
