#### MANAGEMENT REPORT & UNFINISHED BUSINESS

Hot water heater, which is under warranty, at 65 First Street went "bad". We had it designed previously to have 2 hot water heaters. One alone is capable of holding up the building for seniors – other one was a back-up. Mr. Snyder and myself recommended it be done this way, architect concurred. New hot water heater is being replaced on Monday, but we've had no down time for hot water for seniors here at 65 First Street.

2024 June 13 - HHA 2

Before we did this, we had to have a tractor-trailer in parking lot for 5 weeks to give us temporary hot water while we got 2 new units delivered, which was an emergency.

Policari did our State Audit and have report in a week or two. Mr. Katchen, HHA Accountant, will review audit report at July meeting. No issues have been noted in the report. We are now working on 2024-2025 budget, which will be presented at July meeting and adopted at September meeting, if no issues or concerns.

60 Kansas Street elevator work is completed; just waiting for State Inspector to sign-off on it. When that happens, we will dismantle  $2^{nd}$  elevator. It is running, just waiting for inspection.

New bus now has new railings installed. Bus was dropped off there and it is much easier for seniors to walk up/down steps with no worries about someone falling.

Please make every effort to attend the July meeting as we are discussing budget and audit.
