## MANAGEMENT REPORT & UNFINISHED BUSINESS

ED Feorenzo reported there were 2 lockouts last week. Tenants owed quite a bit of money; one moved out a few days prior to lockout; other one moved out day before. Each knowing they couldn't come up with the money. One more lockout is coming next week; Court messed up with their address, HHA refiled. After those 2 people were removed, documents placed on their doors, many other people came in the next day and pay rent. I instructed staff is someone is a month late, we're sending them a Letter of Default immediately. I don't want this getting out of hand. Not only does it help us, but it shows the tenants we are serious and that they need to come up with the money before we take action. They're receiving these letters for 2 months. Our late payments have been going down and all receivable have been going down. Letter we send out to them after 10th of the month is helping a lot. Tenants are paying attention.

NON-PROFIT 30 UNITS – We submitted everything that they requested to attorney; Spencer Bank gave me the notice, they're taking the lien off 60 Kansas Street and we did the PAR58 for the environmental. Mrs. Fox at HUD has everything she needed for the past 2 weeks. Mr. Snyder spoke to our attorney today; he will reach out to here today or tomorrow to find out when she will give us the approval so we can go for the sub-division. I contacted Albert Dibbs from Hackensack; he's still planning on giving us \$1.5 million towards the project. We are still investigating if we should finance this through HHA. We'll have an answer in a week or two. Mr. Snyder called several auditors he knows, it looks very promising.

This past week has been very challenging to the maintenance men. These snowstorms during the night and holidays – I have to say in going to check on them and help them out, they have done a nice job. No slip and falls (knock wood). They've been keeping up on their snow logs; every time they start a plow and salt, it's in the snow log just in case we have a law suit; we have everything documented that we have done.

We are waiting for HUD so we can get this taken care of. As soon as she tells us, we will have another non-profit meeting and I will release the architect to start schematics so we can get an

approval for 30 units. Vice-Chairman Stuart is not on the Board, but she is what you call pro se, she will be involved in meetings and see what's going on and report back to the Housing Authority on the status of it and how it's being rented.

The best thing about this project is it's for Hackensack residents only, which is a win-win for the City.

# OLD BUSINESS – nothing at this time

### **NEW BUSINESS**

Vice-Chairman Stuart got a call from a tenant who asked about the Rec Room at 230 Central Avenue as the sub-station is gone. Do they have a tenant's association? ED Feorenzo said no. V/C Stuart said they wanted to use it, but there's no tenant association to manage it. ED Feorenzo said last time it was used, kids got out of control. If someone wants to approach me, they want to do after school studies, take care of it, have a list of who is coming in and managing, we can do that. They have to contact me.
